NEW LAVENHAM HOUSES UP FOR AWARD

The development of 12 new affordable homes in Lavenham has been shortlisted for the East Anglia Building Excellence Awards 2018.

Commissioned by Babergh District Council, the homes on Meadow Court have been shortlisted in the Best Social or Affordable New Housing Development category.

The development, which saw the construction of the first new-build affordable homes in Babergh in almost 30 years, was the result of close working between Lavenham Parish Council and Babergh District Council to supply new housing to meet local need.

The winners of the awards will be announced on the evening of 29 June at King's College, Cambridge.

SHARED OWNERSHIP / HOUSING

Babergh District Council has taken on the first new Shared Ownership Housing in the district in over 25 years.

The seven new houses – the first of 12 are in Holbrook.

Shared Ownership housing allows homeowners to purchase between 25 and 75% of a property, while paying rent on the remaining share. This allows households who may not otherwise be able to afford mortgages to become homeowners.

LEADER AND DEPUTY OPEN TO QUESTIONS

NEW ONLINE PAYMNET SYSTEM

Babergh have introduced a new online payments system for those buying homes in their districts.

The new system allows those requesting a Local Land Charge Search – which carries with it a search fee – to pay quickly and easily online, via credit or debit card.

Most Land Charge Service customers are solicitors and agents delivering conveyancing services to those buying a house although anyone can request this service regarding any property. In addition to the official search requests, known as LLC1 and CON29 searches, Babergh are also adding a new online form and payment system for personal searches, which include only selected parts of the full official search and this is available now.

HOUSEBUILDING/PLANNING

LAVENHAM TIC

I was pleased to see that Lavenham Parish Council have submitted their nomination to list the Tourist Information Centre at 2 Lady Street, Lavenham, CO10 9RA.

The Community Right to Bid, which was introduced by the Government in 2011 allows community groups to nominate land and/or buildings as Assets of Community Value, which cannot be sold without community groups first being given the opportunity to put together bids to buy the property. These rights last for 5years from confirmation, if successful.
